3-2-1: Adoption³

That certain documents, copies of which are on file in the office of the Zoning and Building Official of the Town of Westcliffe, being marked and designated as the International Building Code, 2006 edition, the International Residential Code, 2006 edition, the International Mechanical Code, 2006 edition, the International Fire Code, 2006 edition, the International Existing Buildings Code, 2006 edition and the International Energy Conservation Code, 2006 edition, EXCLUDING ALL APPENDICES UNLESS SPECIFICALLY ADOPTED BY THIS ORDINANCE, as published by the International Code Council, be and are hereby adopted as the Building Code for the Town of Westcliffe, in the State of Colorado, for regulating and governing the design, construction, demolition alteration, movement and safety of all property, buildings and structures; providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, penalties, conditions and terms of said Building Code on file in the office of the Town of Westcliffe are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 2 of this ordinance. 3-2-2: International Building Code Revised

A. International Building Code:

1. Section 101.1. Insert: Town of Westcliffe
2. Section 101.4.1 Amend to read: Electrical inspections are performed by Colorado State Electrical Inspectors according to the State's adopted Code. A separate permit is required for electrical work.

required, in accordance with the Town of Westcliffe Building Permit Fees Schedule. Fees for Government entities applying for a permit may be reduced by Fifty Percent (50%) at the discretion of the Building Official.

2. Section 103.1 Amend to read: **General.** The Wet Mountain Fire Protection District is hereby named as the Department of Fire Prevention for the Town of Westcliffe. The function of the department shall be the implementation, administration and enforcement of the provisions of this code.

4. Section 111.4 Insert: \$50.00, \$300.00
5. That the geographic limits referred to in certain sections of the 2006 International Fire Code are hereby established as follows:
 - a. Section 3204.3.1.1 Amend paragraph two to read: Storage of flammable cryogenic fluids in stationary containers outside of buildings is prohibited in all Zoning Districts with the exception of Heavy Industrial.
 - b. Section 3404.2.9.5.1 Amend to read: **Locations where above-ground tanks are prohibited.** Storage of Class I and II liquids in above ground-tanks outside of buildings is limited to 500 gallons in Zones CC, HC, RR, SF, MF and MH.
 - c. Section 3406.2.4.4 Amend to read: **Locations where above-ground tanks are prohibited.** The storage of Class I and II liquids in above-ground storage tanks is limited to 500 gallons in Zones CC, HC, RR, SF, MF and MH.
 - d. Section 3804.2 Amend to read: **Maximum capacity within established limits.** With the exception of Heavy Industrial zones, the storage of liquefied petroleum gas, for the protection of heavily populated or congested areas, the aggregate capacity of any one installation shall not exceed a water capacity of 500 gallons. (Ord. 7-2016, eff. 6/2/2016)

- 5. Section 509 Amend: Remove all sections and replace with: 508.1 **Plumbing.** Plumbing inspections are performed by Colorado State Plumbing Inspectors according to the State’s adopted Code. A separate permit is required for plumbing work.
 - 6. Section 708 Amend: Remove all sections and replace with: 708.1 **Electrical.** Electrical inspections are performed by Colorado State Electrical Inspectors according to the State’s adopted Code. A separate permit is required for electrical work.
 - 7 Section 710 Amend: Remove all sections and replace with: 710.1 **Plumbing.** Plumbing inspections are performed by Colorado State Plumbing Inspectors according to the State’s adopted Code. A separate permit is required for plumbing work.
 - 6. Section 908 Amend: Remove all sections and replace with: 908.1 **Electrical.** Electrical inspections are performed by Colorado State Electrical Inspectors according to the State’s adopted Code. A separate permit is required for electrical work.

\$501 to \$2,000	\$24 for the first \$500; plus \$3 for each additional \$100 or fraction thereof, to and including \$2,000
\$2,001 to \$40,000	\$69 for the first \$2,000; plus \$11 for each additional \$1,000 or fraction thereof, to and including \$40,000
\$40,001 to \$100,000	\$487 for the first \$40,000; plus \$9 for each additional \$1,000 or fraction thereof, to and including \$100,000

\$100,001 to \$500,000	\$1027 for the first \$100,000; plus \$7 for each additional \$1,000 or fraction thereof, to and including \$500,000
\$500,001 to \$1,000,000	\$3,827 for the first \$500,000; plus \$5 for each additional \$1,000, to and including \$1,000,000
\$1,000,000 to \$5,000,000	\$6,327 for the first \$1,000,000; plus \$3 for each additional \$1,000 or fraction thereof, to and including \$5,000,000
\$5,000,001 and over	\$18,327 for the first 5,000,000; plus \$1 for each additional \$1,000 or fraction thereof

The Town may from time to time adjust the building permit fees. Inspection fees are included in the building code fee unless re-inspections are necessary. Re-inspections will be billed at the discretion of the Building Code Official and shall not be more than \$50.00. (Ord. 7-2016, eff. 6/2/2016)
